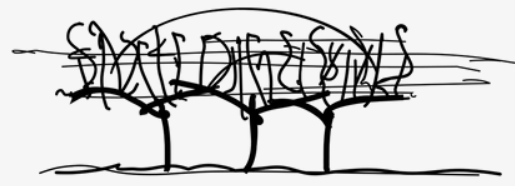

## ADDITIONAL INFORMATION

Set up/inclusions

- Ceremony location
- 32 Americana chairs (no sash) \*additional chairs can be hired
- Square signing table, clothed with two chairs or wine barrel
- Use of ceremony location from 5pm
- Use of the estate for photos
- Use of our outdoor terrace or lawn for pre dinners drinks
- Dining room set for confirmed number of guests
- Dining room wooden chairs for confirmed number of guests
- Long tables set with white linen and napkins
- Use of The Lane cutlery and glassware
- Use of onsite car parking

The Lane Vineyard is a working winery, during vintage we rotate nets over the vines to protect the fruit.

We try not to net vines closer to the estate however sometimes this is unavoidable and can be unpredictable.

The winery can be used in the case of wet or extreme weather for ceremonies with the exception of vintage months.

## TERMS AND CONDITIONS

### 1.CONFIRMATION

To confirm a function booking at The Lane Vineyard ("Us" "We") we require you to pay a security deposit and agree to the following terms and conditions. Until these signed terms and conditions and the deposit are received, we reserve the right to cancel the function booking and reallocate the space. Once a booking is confirmed, you are bound by these terms and conditions. An event order covering all the booking details will be issued as soon as possible after confirmation. Any additional terms set out within the event order become part of these Terms and Conditions.

### 2.CONFIRMATION DEPOSIT

A deposit of \$4000.00 or 25% of the estimated function cost (whichever is the greater) is payable at the time of confirmation.

Deposits are non-refundable.

### 3.MINIMUM SPEND

A minimum spend is required for all functions, this will be outlined in your quote and is not refundable.

Minimum spends are to be made up of food and beverage consumed at the event. Venue hire and external hire costs are in addition to the minimum spend.

### 4.PAYMENT

The minimum spend is due 28 days prior to the event along with any hire costs.

Any remaining balance is due 14 days prior to the event once final numbers are confirmed.

If payment is not received in full by the due date, the function is no longer confirmed and the cancellation policy will apply.

Credit card payments attract a 1.75% service fee.

In the event that items need to be hired in, the cost as specified by The Lane Vineyard, will be passed on to the client in full.

A valid credit card is required to be held by The Lane Vineyard until 7 days following your event should any additional charges be incurred.

The Lane Vineyard does not accept payment by cheque.



## TERMS AND CONDITIONS CONTINUED

### 5.GUEST NUMBERS

Final Numbers are due 14 days prior to the event.

If your guest numbers decrease after the final account has been paid, you will not be eligible for a refund.

### 6.CANCELLATION

In the event that you need to cancel your function the following will apply:

- Cancellations 4 weeks or more from the date of the function will forfeit the security deposit and any non-refundable hire items (including marquee if applicable).
- Cancellations within 4 weeks of the date of the function will forfeit 100% of all monies paid.

### 7.COVID-19 RESTRICTIONS

If The Lane Vineyard cannot host you on your confirmed date due to government Covid-19 restrictions any monies paid can be postponed to a future available date.

Any external hire would be subject to third party terms and conditions.

If your cancellation is due to changes in guest numbers the cancellation policy outlined in .6 above would apply.

### 8.CONSUMPTION

No food or beverages of any kind will be permitted to be brought into the venue for consumption at the function by the client or by guests, invitees or persons attending the function, (with the exception of wedding cakes).

### 9.DIETARY REQUIREMENTS

Please notify us of any dietary requirements a minimum of 14 days prior to the event.

Whilst we make every effort to accommodate dietaries, we cannot guarantee that any product served will be free of allergens. If you or your guests experience anaphylaxis please bring your own EPI Pen.

### 10.BAND/VENDOR MEALS

The Musician's Award stipulates that all entertainers must be provided with a meal. These are provided at a charge of \$40 per person to the client. These will be served at a time suitable to the function manager and head chef. Dietaries for all vendors must be stated prior to the evening as we cannot cater for these on the night.

### 11.ALCOHOL

The Lane Vineyard has a strict no BYO policy. The Lane Vineyard does not offer spirits. Responsible Service of Alcohol: The Lane Wine Company PTY LTD reserves the right (under the Liquor Licensing Act, 1997 – section 125) to refuse service of alcohol to intoxicated or disorderly patrons. These patrons may also be asked to leave the premises. Through the Liquor Licensing Act, The Lane Wine Co. has the duty of care for staff and the patrons and we therefore act accordingly. Liquor service will cease 30 minutes prior to the conclusion of the event.

### 12.PACKAGES

All wedding guests must be on the food and beverage package chosen by the clients. This excludes children and vendors who are on previously chosen menus.

### 13.SET UP AND DELIVERY OF EQUIPMENT

You are responsible for the costs associated with the set up and pack down of external (third party) equipment for the function. All deliveries made to the venue must provide prior notice as to expected arrival and must be marked with the name and date of the function. No deliveries will be accepted between 12 noon and 3pm on any given day, without prior arrangement with management. Whilst every effort will be made to assist in the movement of goods from the loading area to the function area, assistance will be offered on the basis of staff availability. All items are to be picked up the next day at a time negotiated by the function manager.

### 14.MUSIC

You are responsible for providing the music for your event. The function manager remains in complete control over the volume and bass levels at all times during the course of the function.

All Music must end by 11:30pm



## TERMS AND CONDITIONS CONTINUED

### 15.DISPLAYS AND SIGNAGE

Nothing is to be nailed, screwed, stapled or adhered to any wall, door, or other surface or any part of the building. All relevant signage required by law regarding licenses and alcohol service must remain displayed at all times during your event.

### 16.SPECIAL EFFECTS

Smoke machines and pyrotechnics are not permitted. Restrictions on sparklers, candles and any open flames will apply during fire ban season. No wax candles are permitted in the venue without vases supplied by the client.

No confetti or confetti-like substances are permitted anywhere in the venue including the surrounding estate. Use of these substances will attract a cleaning fee.

### 17.SMOKING POLICY

Smokers are asked to use the designated smoking area and bins provided. Cigarette butts left on the ground will incur a cleaning fee.

### 18.DAMAGES

Clients holding a function at The Lane Vineyard are fully responsible for any damages sustained to the premises, its contents and property owned or in the care or custody of The Lane Vineyard. This liability extends to the entire estate and vineyards. Any cost of repairs due to damage caused by the client, or guests of the client will be invoiced to the client and charged to the credit card on file.

### 19.ENTIRE AGREEMENT

Subject only to variations specified in a subsequent event order signed by both parties, the attached document and these terms and conditions constitute the entire agreement of the parties and shall supersede all prior offers, negotiations and agreements in connection with the function.

### 20.BASIS OF AGREEMENT

Performance of this agreement is subject to labour troubles, disputes, strikes or pickets, accidents, government (Federal, State, Local requisitions), restrictions upon travel, transportation, food, beverage or supplier's equipment failure and other causes which are beyond the control of The Lane Vineyard. In no event shall The Lane Vineyard be liable for the loss of profit or consequential damages suffered by the client, where based on breach of contract, warrant or otherwise. In no event shall The Lane Vineyard's liability be in excess of the estimated function cost.

### 21.LIABILITY

If The Lane Vineyard has reason to believe that a function will have an adverse effect on the venue, its security or reputation, it reserves the right to cancel the event.

### 22.LAWS AND REGULATIONS

At no time will the client commit any act or permit its employees, agents or guests to commit any act that is illegal or offensive or is in breach of the venue's rules. Nor can any such act breach any statutes, by law, orders, regulations or other provisions having the force of the law including but not limited to the venue liquor license and fire obligations.

### 23.CLIENT RESPONSIBILITY

The Lane Vineyard will not accept any responsibility for damages or loss of merchandise left in the venue or function area prior to or after the function. Guest's goods must be removed from the venue by 11am the day following the conclusion of the function. The client is required to inform all relevant persons involved in the organizing of the function (including contractors), of the venue's Terms and Conditions.

### 24.COMPLIANCE

It is understood that the client will conduct their function in an orderly manner in full compliance with the venue management and all applicable laws. The venue reserves the right to exclude or eject any and all objectionable persons from the function or the premises without liability.
